Flight time and landing statistics

Anyone who owns or operates an aircraft, or who has had a permit to carry out aviation activities for the purpose of acquisition, shall submit information about his flight time to the Swedish Transport Agency.

The information regarding flight time submitted to the Swedish Transport Agency is used for compilations of flight safety-related statistics. The compilation of flight time production is done annually.

The statistics are published here among other things on the Swedish Transport Agency's website. The data also form the basis for Sweden's reporting to the EU and ICAO.

Flight hours are an important component for following flight safety developments.
